2. Wenn Sie ein drahtloses Modell haben, schließen Sie die Antennen an die Antennenstecker an.



3. Stecken Sie die Edimax-CD in Ihr CD-ROM-Laufwerk und klicken auf "Setup Utility", um das Dienstprogramm EdiView Finder zu installieren. Der Einrichtungsassistent wird Sie durch den Einrichtungsvorgang führen.



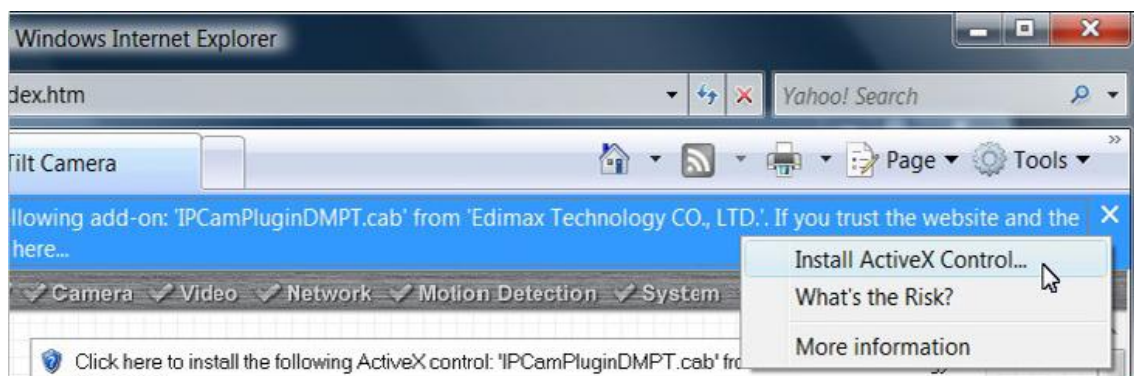
4.
